MARCH 1-2, 2022

Champions of Children Conference - Hybrid - \$250

This 13th annual conference will feature 14 local, state, and national speakers. Topics chosen are timely to MDTs and challenges surrounding physical and sexual abuse cases seen at Children's Advocacy Centers.

MARCH 16-17, 2022

Illinois Prosecutor Institute - Virtual - Free

This two-day training institutes for child abuse prosecutors and members of MDT teams on opening statements, closing arguments, preparing children for court, cross-examination of defendants and defense witnesses, as well as other select topics.

MARCH 2022 - date TBA

VOCA Training - Virtual - Free

This training will cover several VOCA topics. These topics will include, but not limited to: PFRs, budget modifications, VOCA Quarterly Reports, etc. We will also use a good portion of the time answering all VOCA related questions from participants.

APRIL 2022 - date TBA

FY23 VOCA Grant Application Training - Virtual - Free

This training will cover the FY23 grant application process. Including but not limited to due dates, the NOFO, review of allowable costs and non-allowable costs, budget templates, and application process in AmpliFund.

APRIL 18-22, 2022

ChildFirst Illinois - Virtual - \$50

ChildFirst training enhances the education of front-line child abuse professionals. Participants will learn this protocol and how to properly conduct a forensic interview.

APRIL 26, 2022

Advocate Round Tables Quarterly - Virtual 10am-11:30am - Free

These less structured meetings are designed for advocates to network, and share ideas on overcoming challenges.

MAY 2022 - date TBA

Amplifund Training - Virtual - Free

This training will cover all required functions expected to be completed in AmpliFund. The training will be led by a rep from AmpliFund via Zoom. This training will be geared for all employees at CACs that deal with AmpliFund to participate.

MAY 16, 2022

Prepare and Predict Presenting Evidence - Virtual - Free - 1pm-4:30pm

The prepare and predict presenting evidence method allows the forensic interviewer prepare victims for the evidence that will be presented to them in the forensic interview process, while providing them an opportunity to predict what they are about to see and discuss with the forensic interviewer.

MAY 18-20, 2022

Child and Family Traumatic Stress (CF-TSI) - Virtual - \$145 -

This evidenced-based psychotherapy approach is focused on reducing the traumatic stress symptoms and interrupting PTSD in the aftermath of traumatic experiences. Participants will be required to have 8 mo. of follow up consultation after the training.

MAY 18, 2022

MDT Coordinator Round Table - Virtual - Free - 10am - 11:30am

These less structured meetings are designed for MDT facilitators to network, develop new facilitation tactics, & share ideas to assist their MDTs in identifying and addressing challenges that impact case outcomes.

JUNE 15-16, 2022

Interviewing Beyond Sexual Abuse - Virtual - Free

This training is for previously trained forensic interviewers to learn how to specifically explore issues beyond sexual abuse. This training will focus on the importance of interviewing children about a multitude of issues including physical abuse, witness to violent crime, and psychological abuse.

PART 1: VIRTUAL LEADERSHIP SERIES

JUNE 15, 2022

Leading Through Change - Virtual. Presenter: Andy Zimney

This training will explore the 4 R's of Innovative Teams, the 4 D's of Innovation, & the IdeaScape. You will gain knowledge about the 4 key behaviors of change-oriented innovated teams, a process model for adding new ideas & how to leverage ideas through change.

JUNE 22 - 23, 2022

Advocacy Essentials - Virtual - Free

This training will assist advocates in meeting the essential components as required by the NCA Standard of Victim Advocacy. Through hands-on practice, victim advocates will learn to create interventions to meet victims' needs.

Advanced TF-CBT Training - Virtual - Free

Advanced issues surrounding implementation of TF-CBT will be taught including: Complex Trauma, Child Trauma, Grief, Traumatic Separation, Ambiguous Loss, Engagement Research, Sexually Abused Youth, Socratic Questioning, and Trauma Resilience. Supervisors will be taught on June 30th about Fidelity Monitoring, Overcoming Supervisory Challenges, and Reflective Supervision.

JULY 2022 - Self Paced

Evidenced Based Assessments Cohort - Virtual - Free

The focus of this program is to train mental health clinicians in the use of standardized assessments to inform the delivery of mental health services to abused and/or traumatized children. Clinicians who participate in this program will be eligible for assessments to use in their practice. Consultation calls will be required for 60 min for the following 10 weeks to successfully complete this program.

JULY 19, 2022

Advocate Round Tables Quarterly - Virtual 10am-11:30am - Free

These less structured meetings are designed for advocates to network, and share ideas on overcoming challenges.

JULY 21-22, 2022

NCA Accreditation Training - Virtual - Free

This training is geared towards CAC Directors and those responsible for NCA accreditation. The new 2023 Accreditation Standards will be the primary focus of this training, and participants will gain knowledge to prepare for these new standards in practice, written policy, and practical application.

AUGUST 3-4, 2022

How to Best Support Kids at Trial - Springfield - \$40

This training is for forensic interviewers, attorneys, and therapists to learn how to support the child victim through the court process. Forensic Interviewers will gain a deeper understanding of their vital role in the court processes. Attorneys will enhance their knowledge in motions to file in CAC child victim cases, and how to use all members of the team for court. Also, the therapist role in court will be examined, and how to use this vital witness.

Fee includes lunch each day. Participants are responsible for their own hotel stay.

PART 2: VIRTUAL LEADERSHIP SERIES

AUGUST 15, 2022

Trauma-Informed Leadership: The Balance of Compassion and Accountability - Virtual. Presenter: Lisa Conradi

This presentation will provide attendees with an overview of the principles of a trauma-informed approach to leading teams and organizations, drawing from literature on effective leadership, implementation science, and trauma-informed care principles.

AUGUST 17, 2022

MDT Coordinator Round Table - Virtual - Free - 10am - 11:30am

These less structured meetings are designed for MDT facilitators to network, develop new facilitation tactics, & share ideas to assist their MDTs in identifying and addressing challenges that impact case outcomes.

AUGUST 23-25, 2022

Stopping Technology: Facilitated Abuse of Rural Kids Prosecutor Symposium (STARK) - Springfield - \$60

Topics will include: Internet 101, Digital Forensics 101, Child Exploitation Investigations 101, Admissibility of Social Media and Digital Evidence. This symposium will include a brief experiential component in which select attendees will attempt to admit digital evidence in the face of defense objections.

PART 3: VIRTUAL LEADERSHIP SERIES

SEPTEMBER 14, 2022

Courageous Conversations - Virtual. Presenter: Andy Zimney

What are the 3 components in having a crucial conversation? Participants will learn about high stakes, differing views, and strong emotions. These conversations will not always involve big issues, but they will affect the quality of our lives both personally and professionally.

SEPTEMBER 27-29, 2022

Crime Scene To Trial - Springfield - \$60

Teams of four or more will learn detailed instruction of a crime scene, and how unimportant details can become critical at trial. This training includes interrogation, photography of a crime scene, witness interviews, and a crime scene investigation in a mock house.

Fee includes lunch each day. Participants are responsible for their own hotel stay.

OCTOBER, 2022 - date TBA

Direct vs. Indirect Cost Rate Training - Virtual - Free

This training will include, but not limited to: overview of what are indirect costs, how to calculate indirect costs, de minimis (10%) rate, and Modified Total Direct Costs (MTDC).

OCTOBER 3-7, 2022

ChildFirst Fall- Springfield - \$250

ChildFirst training enhances the education of front-line child abuse professionals. CAC affiliated MDT members will learn the ChildFirst protocol and how to properly conduct a non-leading fact finding forensic interview.

OCTOBER 17, 2022

Addressing Secondary Traumatic Stress & Improving Workforce Wellbeing Through Reflective Supervision - Virtual. Presenter: Lisa Conradi

This presentation introduces the key skills of reflective supervision to address secondary traumatic stress and improve workforce well being. This presentation will include practical skills, strategies, and resources developed to support organizations and individuals in using reflective supervision.

Director's Conference - Champaign - \$40
